



## Weekly Report (July 21-27, 2023) on the Second Tranche of Stellantis Share Buyback Program

AMSTERDAM, July 28, 2023 - Stellantis N.V. (“Stellantis” or the “Company”) announced today that pursuant to its Second Tranche of the Share Buyback Program announced on June 7, 2023, covering up to €500 million to be executed in the open market during the period between June 7, 2023 and September 7, 2023, it has repurchased the following common shares in the period between July 21 up to and including July 27, 2023:
